

KC Proposal Notification for PIs, Co-PIs and Other Key Personnel **Ouick Reference Card**

Overview

This Quick Reference Card explains the Kuali Coeus (KC) proposal notifications sent to all Principal Investigators (PIs) and Co-Principal Investigators (Co-PIs) for every KC proposal. This notification may also be sent to other Key Personnel based upon Sponsor specific requirements.

Procedure

All PIs and Co-PIs named on a KC proposal must complete Proposal Certification, which includes FCOI screening questions, before a proposal may be submitted to route for internal approvals. Certain Sponsors may also require named Key Personnel to complete FCOI screening questions.

In addition, the KC Proposal Notification also contains information on Federal training requirements as required for certain sponsors.

- 1. You will receive an email notification with the Subject "Regarding your Involvement in Development Proposal...". The notification is triggered during the proposal development in KC by the proposal Aggregator (Administrator preparing your proposal).
- 2. The email contains basic information such as PI, Lead Unit, Proposal Number, Sponsor, Deadline Date and Title. For those required to certify, it contains a direct link to **Certify** and additional information on Federal Training and Compliance requirements.
- 3. Click the links to go directly to the KC Certification screen or to be brought to resource webpages for more information on certification or Sponsor requirements.

Please note that at this time, Principal Investigators (PIs), Co-Investigators (co-PIs), and Other Senior/Key Personnel on PHS, DOD, and NASA-funded research are required to have valid COI train CITI helps meet that requirement. Now is a good time to check whether your COI training in CITI is still valid. If it has expired or will expire during the research period, please retake it now to avo unfulfilled. The award will remain on hold until the training requirement is completed.

Research Security Training Required for Federal Agencies:

MIT requires all principal investigators (PIs), co-PIs, and other senior/key personnel engaged in federally funded research ("covered individuals") to complete research security training. This requi Presidential Memorandum-33 (NSPM-33).

Note: For NSF and DoE proposals, you must complete the Research Security Training before this proposal can begin routing.
